House Bill 2 Implementation

- **Secretary Layne established a working group to oversee implementation**
 - **Deputy Secretary Donohue**
 - **Commissioner Kilpatrick, or designee**
 - **Director Mitchell, or designee**
 - **VDOT district administrator**
 - **VDOT central office executive**
 - **Staff from the Office of the Secretary of Transportation**

House Bill 2 Implementation

- **Workgroup will establish sub-workgroups**
 - **Funding and Programming**
 - **Measuring Outcomes**
- **Workgroup will also be responsible for:**
 - **Outreach and engagement with public and other stakeholders**
 - **Facilitating regional weightings of prioritization factors**

Funding and Programming

- **Update of Six-Year Improvement Program to ‘de-allocate’ funds from projects subject to prioritization process**
 - **Draft revised FY15-20 SYIP released in September/October**
 - **Public hearings held in conjunction with Fall SYIP public hearings**
 - **Board considers revised FY15-20 SYIP at November meeting**
- **Will work to align prioritization process with preliminary engineering starts to develop project pipeline**

Measuring Outcomes

- **Responsible for determining how and when the impacts of candidate projects are examined**
- **Will be establishing a peer group of experts from outside of Virginia to provide insights and guidance**
 - **MPOs, University Transportation Centers, think tanks, etc**
